Martyr's dad jailed for building memorial on 'encroached' land

Patna: Father of a Galwan Valley martyr was thrashed, arrested and sent to jail on the charges of "encroaching village road" by building a memorial in his son on a plot of government land at his village Chakfatah under Jandaha police station area in Vaishali district.

A strong police team from Jandaha reached Chakfatah on the night of February 25-26 and picked up martyr Jai Kishore Singh's father Raj Kapoor Singh, thrashed him and took him to the police station on the charges of encroaching the village road. The martyr's father was sent to jail the next day on Sunday.

Police said the martyr's father had been arrested under various sections of the SC/ST (Prevention

of Atrocities) Act on the complaints of his co-villager Harinath Ram, who alleged that Singh had encroached certain portion of his private land as well as of the village road. When Jai Kishore's father was building the memorial, some villagers protested and asked him to build the structure either on his own land or the government land in front of his own. But he forcibly built the memorial on the government plot in front of the land belonging to Harinath, a police officer of Jandaha police station told TOI on Tuesday.

The matter took an ugly turn on January 23 when Harinath submitted a written complaint with Jandaha police station against Singh for allegedly encroaching upon his as well as some portion of the village land leading to his house. After investigation, sub-di-

visional police officer (SDPO), Mahua, Poonam Keshri asked the martyr's father to relocate the memorial as it was built on the government land by encroaching a portion of the village road and that too without taking any permission from the authorities concerned.

As the martyr's father refused to relocate the memorial, he was arrested.

The SDPO said, "Repeated requests were made to the martyr's father to relocate the memorial as it was built on the government land and by encroaching a portion of village road and the pathway of Harinath. The martyr's father has huge land near the memorial, but he preferred to build the structure in front of his opponent's land, leading to encroachment and dispute between two groups."
